## **Report of the Twenty-sixth Session of the Committee on Fisheries 2005**

the twenty sixth session of the committee on fisheries cofi was held in rome italy from 7 to 11 march 2005 the committee reviewed the issues of an international character and the programme of work of the fao fisheries department in fisheries and aquaculture the committee commended fao on its report on the implementation of the code of conduct for responsible fisheries and its associated instruments and called for a decade of implementation of the various instruments developed to ensure responsible fisheries the committee called upon members to accept ratify or accede to as appropriate these instruments the committee encouraged fao to elaborate additional guidelines in support of the code including one for the implementation of the international plan of action for the management of fishing capacity the need to initiate international negotiations on the monitoring of fishing vessels within the framework of the code of conduct concerning its implementation was underlined the committee welcomed the revised code and voluntary guidelines for the design construction and equipment of small fishing vessels that had been prepared by fao the international labour organization and the international maritime organization the committee expressed concern at the proliferation of international fora addressing fisheries matters some of which lacked sound technical and scientific bases for discussion the fao s medium to long term rehabilitation strategy for the fisheries and aquaculture sector in countries affected by the tsunami was endorsed guidelines on ecolabelling of fish and fishery products were adopted the committee agreed to give greater attention to small scale fisheries and to allocate more resources in their support the committee expressed its appreciation to fao and donor countries for giving greater attention to small scale fisheries and for allocating more resources in their support it welcomed the advance version of the code of conduct guidelines on enhancing the contribution of small scale fisheries to poverty alleviation and food security the committee stressed that cofi and fao should continue to provide leadership and maintain an assertive role in fisheries the committee commended fao for the improvements made in the presentation of the medium term plan and preliminary programme of work proposals for 2006 2007 the committee underlined that additional allotments should be made to the major programme 2 3 fisheries book jacket

in 1991 the environmental protection agency epa and the agency for toxic substances and disease registry atsdr asked the national research council nrc to provide technical guidance for establishing community emergency exposure levels for extremely hazardous substances ehss pursuant to the superfund amendments and reauthorization act of 1986 as a result the nrc published guidelines for developing community emergency exposure levels for hazardous substances in 1993 and standing operating procedures for developing acute exposure guideline levels for hazardous substances in 2001 providing updated procedures methods and other guidelines used by the national advisory committee nac on acute exposure guideline levels aegls for hazardous substances for assessing acute adverse health effects stemming from this report the nac has developed aegls for at least 270 ehss there are currently three aegls aegl 1 aegl 2 and aegl 3 aegl 1 is the airborne concentration of a substance above which it is predicted that the general population could experience notable discomfort irritation or certain asymptomatic nonsensory effects these effects are not disabling and are transient and reversible once exposure is stopped aegl 2 is the airborne concentration of a substance above which it is predicted that the general population could experience irreversible long lasting adverse health effects or an impaired ability to escape aegl 3 is the airborne concentration of a substance above which it is predicted that the general population could experience life threatening health effects or death on april 22 24 2013 the nrc established committee on acute exposure guideline levels 2013 met to review aegl documents approved by the nac the committee members were selected for their expertise in toxicology medicine industrial hygiene biostatistics and risk assessment twenty second interim report of the committee on acute exposure guideline levels presents a review of aegls for various chemicals including acrylonitrile halogen fluorides tellurium hexafluoride and thionyl chloride

the committee expressed concern about the level of fishing capacity which was higher than prior to the 2004 tsunami in some of the areas affected by the disaster and recognized that it called for the design and implementation of sustainable and effective fisheries management arrangements that included a gradually phasing out fishing overcapacity monitoring

access and livelihood considerations the committee reaffirmed its trust in fao to play a coordinating role in advancing the global aquaculture agenda and highlighted the importance of addressing socio economic impacts of aquaculture and other issues such as improving planning and policy development at national and regional levels the committee agreed to give greater attention to small scale fisheries and welcomed the convening of a broad based international conference focusing specifically on small scale fisheries

the mod s financial settlement in the next comprehensive spending review must be made in the light of the need to retain a credible deterrent capacity in the country s armed forces the committee welcomes the emphasis that the government places on the importance of cyber defence and the commitment of resources to a new cyber strike capability but the difficulty in identifying actors in a cyber attack makes the ability to deter that much harder similar questions arise in deterrence against the asymmetrical threat of terrorism as it is difficult to identify interests and groups against which a response can be legitimately targeted the committee is calling on the mod to set out how it can make clear that both cyber and terrorist attack will elicit an appropriate and determined response looking at the nuclear deterrent the committee points out that the uk s ability to effect a nuclear response is not credible in dealing with all threats and so strong conventional deterrence is also required and given the importance of communication to the concept of deterrence investment in diplomatic and intelligence assets must be integral to the uk s security apparatus the committee concludes that it would be naive to assume that a decision not to invest in the nuclear deterrent would release substantial funds for investment in other forms of security the committee believes that the decision on the retention of the nuclear deterrent should be made on its own merits
