rule 506 an unlimited amount of money may be raised in offerings relying on one of two possible rule 506 exemptions similar to rule 505 an issuer relying on rule 506 b may sell to an unlimited number of accredited investors but to no more than 35 non accredited investors

rule 506 of regulation d provides two distinct exemptions from registration for companies when they offer and sell securities companies relying on the rule 506 exemptions can raise an unlimited amount of money

rule 506 of regulation d of the securities act of 1933 the securities act provides for a private placement exemption from federal securities registration which is increasingly being used by companies seeking to raise capital prior to going public

rule 506 c permits issuers to broadly solicit and generally advertise an offering provided that all purchasers in the offering are accredited investors the issuer takes reasonable steps to verify purchasers accredited investor status and certain other conditions in regulation d are satisfied
